## Sovos VAT Integration-as-a-Service (laaS)

This Data Sheet is effective for orders placed on or after December 08, 2023.

This Data Sheet describes the following Cloud Solutions to be provided by the Sovos Compliance LLC affiliate identified in the Order Form that includes these products ("Sovos") to the customer named on an applicable Order Form (the "Customer") in accordance with this Data Sheet:

- Sovos VAT IaaS Mapping Customization REGION: Provides a flexible, IaaS Layer (and associated Design Services) that transforms the Customer's Data Inputs into useable Mapping Profiles that can be consumed by supported Sovos compliance Products that have been contracted by the Customer.
- Sovos VAT laaS Custom Communication REGION: Provides a flexible laaS Layer that delivers End Points to expose Sovos Products contracted by the Customer via alternative communication mechanisms outside of Sovos standard API's and standard connectors.
- Sovos VAT Compliance SAP Framework Saudi Arabia: Provides SAP-based customizable solution to comply with Saudi Arabia's regulatory requirements.
- Sovos VAT elnvoice SAP Framework France: Provides the SAP-based Framework to extract and restitute invoicing data for Inbound and Outbound elnvoice and e-Reporting.
- Sovos VAT elnvoice SAP Framework Hungary: Provides SAP-based customizable solution to comply with Hungary's RTIR inbound and outbound elnvoicing and/or eReporting regulatory requirements.
- Sovos VAT KSeF SAP Framework Poland: Provides SAP-based customizable solution to comply with Poland's regulatory requirements.
- Sovos VAT LROE SAP Framework Bizkaia: Provides the SAP-based Framework to connect to the Sovos Cloud solution reporting purchase and sales transactions to the Bizkaia Tax Authority Platform.
- Sovos VAT TicketBai SAP Framework Bizkaia: Provides the SAP-based Framework to connect to the Sovos Cloud solution generating the TicketBAi XML reporting file and TicketBai Sales invoice.
- Sovos VAT Outbound eInvoice SAP Framework Romania: Provides SAP-based customizable solution to comply with Romania's regulatory requirements.
- Sovos VAT SAP Framework Italy: Provides SAP-based customizable solution to comply with Italy inbound and outbound elnvoicing regulatory requirements.
- Sovos VAT SII SAP Framework Spain: Provides SAP-based customizable solution to comply with Spain, Canary Islands, Bizkaia, Gipuzkoa eReporting regulatory requirements.

## 1 DEFINITIONS.

- 1.1 "laas Layer" means cloud-based, integration software required to create, maintain and support customized processes for mapping and/or communication flexibility.
- 1.2 "Data Input" means the data structures agreed by Sovos and Customer that the Customer will deliver to the Sovos IaaS Layer, and maintain, including all mandatory information required to fulfill contracted Sovos compliance services.
- 1.3 "Mapping Profiles" means the mapping and transformation of Data Inputs into specific Sovos usable data set(s).
- 1.4 "Design Services" means the availability of expert resources to design, configure, and implement the initial required set of Mapping Profiles based upon the agreed Data Inputs using Sovos Best Practices.
- 1.5 "Sovos Best Practices" means the use of specific mapping or communication definitions according to Sovos understanding of local compliance requirements. Such best practices include input file formats as well as communication protocol restrictions according to the compliance needs of each contracted compliance jurisdiction.
- 1.6 "End Points" means any of the following supported communication

mechanisms: sFTP, AS2, S3, Custom API integrations, subject to Sovos Best Practices.

- 2 <u>DATA AVAILABILITY AND ACCURACY</u>. Customer is solely responsible for the accuracy of Customer's data imported into the System. Sovos mapping customization focuses on the transformation of data for local requirements, but not in the creation of Data Inputs.
- 3 PRODUCTS. All Sovos Cloud Software products listed above are licensed separately. Any changes to the initial Data Inputs will be agreed separately by the Parties and may require additional Sovos Services to be contracted through a SOW or a Change Order. The SAP Framework Products included in this data sheet are Add-On offerings to the corresponding Sovos Compliance Network [COUNTRY] that provides a customizable SAP-based solution to enable integration of supported SAP applications with the cloud-based Software.
